PART 4: PAYMENT DETAILS / TERMS AND CONDITIONS
Automatically effective at time of enrolment

Aim: It is the aim to not leave any player paying for lessons and not receive them, however as per many sports and other activities this needs to be limited.

Therefore we need to implement the following conditions:

No refunds will be given under any circumstances. Credit towards next Terms coaching may be provided in some instances at the Director's (Brad McMillan) discretion.

To enable our program to remain viable we have guidelines on refunds. This is because court hire, lights, coaches wages, and the classes we run needs to be arranged for an entire term in advance.

- **Bookings are per full term and must be paid in full upfront no later than week one of term (unless otherwise agreed on). Failure to pay before the due date will result in a late charge fee of 10%**

Unfortunately, we cannot take casual bookings or pro-rata weeks you may be away

- **Cancelled group lessons/cardio/squads due to:** (washout/heat-out/coach availability) will be offered one day/time for a group makeup lesson. Non-attendance to the makeup lesson forfeits the lesson fee. Lesson time duration may be extended (agreed upon) in future weeks to makeup missed lessons also.

Failure to give required notice for any Endeavour Tennis session will result in class being forfeited. Makeup time options are subject to class times and availability.

- **Cancelled group lessons due to player cancellation:**
 - Must provide 24 hours' notice via SMS
 - Have a maximum of 2 cancellations per term (and these cannot be carried over to next term)
 - One day/time will be offered as a makeup. Not attending this makeup will deem the lesson forfeited
- **Cancelled private lessons due to the player cancellation:**
 - No more than 2 per term
 - Must provide **minimum** 6 hours' notice
 - Makeup times may include weekends/school holidays
 - Unavailability for the makeup lesson time offered will result in forfeiture of the lesson
